Unit of Competency: TLILIC0011 Licence to operate a reach stacker (greater than 3 tonnes capacity)

Who is the course designed for?

This course is designed for new entrants to, or those already working in various retail, wholesale, warehousing construction, farming, etc who require licensing under the "Standard for licensing of persons conducting high risk work". Completion of this qualification is required for licencing eligibility.

The course provides a pathway to obtain a reach stacker licence - class RS - and can lead onto a further qualification in the TLI - Transport and Logistics Training Package. Legal limitations or pre-requisites exist on this qualification that may affect the obtaining of a licence from the licencing authority.

This qualification <u>does not</u> allow operation of the LF class - Forklift. Please enquire if you are unsure as to which licence is required.

How is this course delivered?

Learners must first undertake the Nationally Recognised Training unit of competence TLILIC0011 Licence to operate a reach stacker. This unit has both theory and practical training and assessment elements. Once you have been deemed competent in the TLILIC0011 Licence to operate a reach stacker unit, you then undertake the formal High Risk Work licence assessment.

Qualifications

Statement of Attainment for TLILIC0011 Licence to operate a reach stacker – *issued by Forkpro Australia*. High Risk Work Licence for RS class – *issued by SafeWork NSW, WorkCover QLD or WorkSafe ACT*.

Individual requirements.

You are eligible to enrol in this course if you:

- are at least 18 years of age.
- must provide their Unique Learner Identifier (see www.usi.gov.au).
- have sufficient language, literacy and numeracy skills at a level that enables the safe performance of high risk work.
- can provide 100 points of ID to confirm your current address, DOB, signature and photo identity.
- live in the state or territory in which the course is being conducted (exemptions may be possible please contact the office manager on 1300 789 606 prior to enrolment to discuss).

Course outline.

- Potential workplace hazards are identified
- Risk control measures are identified consistent with regulatory requirements and the hierarchy of control
- Appropriate Reach Stacker truck is selected in accordance with load and workplace conditions
- Working area is inspected to determine appropriate paths for moving loads and Reach Stacker truck in accordance with workplace conditions
- Methods for communicating are identified and confirmed in accordance with workplace procedures
- Prior to operation, Reach Stacker truck is visually checked for any damage or defects
- All signage and labels are checked to ensure they are visible and legible, in accordance with the appropriate standard
- All controls are located, identified and confirmed
- Pre-start operational checks are carried out in accordance with manufacturer specifications and workplace procedures
- Reach Stacker truck is started in accordance with manufacturer specifications and workplace procedures, and is checked for any abnormal noise
- Post-start operational checks are carried out in accordance with manufacturer specifications and workplace procedures
- All Reach Stacker truck functions and safety devices are tested to their maximum in accordance with manufacturer specifications and workplace procedures
- Issues, defects and damage identified during routine checks are reported and recorded in accordance with workplace procedures, and appropriate action is taken
- Weight of load is assessed to ensure compliance with Reach Stacker truck data plate specifications
- Appropriate hazard prevention/control measures are implemented and communicated to personnel in the work area
- Reach Stacker truck is operated at a safe speed in accordance with manufacturer specifications and workplace procedures
- Loads are moved and placed to ensure stability of material and avoidance of hazards.
 - o The Learner is required to conduct a test lift.
 - The Learner must safely demonstrate transferring, stacking and unstacking a minimum of four lifts as specified below:
 - o Stack and unstack one container at least 3 containers high
 - o Stack and unstack one container two containers high and two containers deep
 - o Stack and unstack one container at the greatest height allowed
 - Stack and unstack one container using stabilisers (if fitted)
 - o Travel with all loads.
 - o The containers being lifted must be of at least 50% of the configuration of the MRC of the reach stacker.
- Load movement is monitored constantly to ensure safety of personnel and load, and structural stability
- Unplanned and/or unsafe situations are responded to in accordance with workplace procedures and emergency plans
- Reach Stacker truck is parked to avoid hazards

- Reach Stacker truck is shut down in accordance with manufacturer specifications and workplace procedures
- Routine post-operational Reach Stacker truck checks are carried out in accordance with manufacturer specifications and workplace procedures
- Reach Stacker truck is secured to prevent unauthorised access/use
- All defects and damage are reported and recorded in accordance with manufacturer specifications and workplace procedures, and appropriate action is taken

What does the course offer?

The program has been organised to provide Learners with general skills, background information and specific knowledge about operating a reach stacker, which is then applied in discussion, questioning, role-plays and practical application for the industry specific unit.

The program is delivered 'on-the-job' at the client's premises (so long as the strict site resource requirements can be met). Training delivery combines face-to-face trainer led theory classes and practical sessions. In most cases there will be no more than 7 Learners in any class.

Learners are provided with all required pre-course material including a training manual that covers all parts of the course. Review questions are available within the manual and can be completed before attending the course. Additional material will be made available during training sessions if required.

Forkpro Australia, as far as is practical, will ensure that employers and Learners are kept informed of their progress throughout the training and assessment process.

What if I have a disability, learning difficulties or cannot write in English?

Learners enrolling in High Risk Work licence courses must have English skills at a level that enables the safe performance of high risk work. During the assessment no use of interpreters is allowed. It is important to evaluate these skills prior to deciding to enrol.

Support can be offered in various forms such as:

- Language Literacy and Numeracy evaluation.
- Verbal assessments.
- Additional training if required.
- Referral to support organisations.

It is best to discuss your situation prior to enrolling, as we may be able to offer a varied course structure or put in place some other strategies before enrolment. There are 2 sections of the course – training and assessment for the unit of competence and the final high risk work licence assessment. The trainer must ensure that Learners can demonstrate the required level of competence before allowing the Learner to proceed to the final high risk work licence assessments stage. How are Learners assessed?

- There are 2 separate assessments that must be completed:
 - o Assessments to complete the unit of competence. (Conducted during class time).
 - o Assessments to complete the High Risk Work Licence. (Conducted on the final day).
- There will be a theory, calculations and practical element of the of both assessments.
- The theory test answers can be given orally if circumstances require. It is a closed book test and no outside assistance is permitted.
- The calculations can only be completed in writing no oral test is permitted. It is a closed book test and no outside assistance is permitted.
- For the practical test you will be required to complete set tasks using a compliant reach stacker.

Site resource requirements.

It is a requirement that the following be in place for on-site training delivery. If any of the following is not available, or you are unsure please advise so we can discuss alternatives.

- The Reach Stacker must be in safe operating condition and complies with the requirements of the State or Territory legislation. There must be an operator's manual, pre-operation checklist. Maintenance records must also be available.
- A working zone for the reach stacker assessment.
- The assessor must ensure the weather conditions are suitable for conducting assessment and there is no risk to the safety of the Learner or others.
- Workplace and task specific risk control measures such as barriers to create pedestrian zones, signage and the like.
- A reach stacker container and associated equipment for the purposes of the performance assessment.
- A reach stacker that covers the operation of a reach stacker greater than 3 tonne capacity, incorporating a boom and spreader for container handling.
- Suitable 20 ft or 40 ft containers for the purposes of the performance assessment.
- Appropriate communication systems. For example, two way radio and/or whistles.
- Reach stacker operational and service logbooks and load charts.
- Manufacturer's operation manual.
 - o Note: the assessor is to confirm that the Learner has the appropriate PPE when making arrangements to conduct the assessment, if the Learner does not have, or cannot obtain the appropriate equipment, the assessment must not be undertaken.
- Where the Learner is to provide their own safety equipment, as required by the risk assessment for the location at which the assessment is to be undertaken, this equipment will include:
 - Safety helmet (where required)
 - o Appropriate footwear
 - o High visibility vest or other similar clothing and;
 - O Other protective clothing and equipment as appropriate.

*Special notes:

You will be required to pay SafeWork NSW / WorkSafe ACT / WorkCover QLD the necessary application fee (refer to the local WHS regulator website for current fees). This fee is not part of the license assessment charge levied by Forkpro Australia.

The application must be lodged in the required manner within 60 days of successful assessment. In NSW and QLD the interim license expires at this point. In ACT there is no interim licence issued, the applicant must wait for the licence card to be issued.

In the case of unsuccessful 1st assessment a re-assessment will be required. Re-assessments must be conducted within 90 days of the original assessment otherwise the full assessment must be undertaken. An additional fee will be charged for a re-assessment. These fees are outlined in the Learner Pre-enrolment booklet available at http://forkpro.com.au/Learner-support.

NOTE: In NSW and QLD the RTO must advise SafeWork NSW/WorkCover QLD of the time, date and location of any assessments being conducted. These authorities may exercise their right to have an Officer oversee/audit this assessment process, even if this is on client premises. The authorities will not notify of their intention to attend prior.
