HIGH RISK WORK LICENCES







1. Forklift Licence (LF)

TLILICO003 Licence to operate a forklift truck

This course provides a pathway to obtain a forklift licence (class LF). As onsite training specialists, we conduct this course for your staff, at your premises. The course can be contexualised to your site's specifications, meaning your staff will be trained on your equipment in your working environment.



2. Order Picking Forklift Licence (LO)

TLILICO004 Licence to operate an order picking forklift truck

This course provides a pathway to obtain an order picker licence (class LO). This course provides skills and knowledge to safely operate an order picker. It blends theory with hands-on practice, teaching maneuvering, load handling, and adherence to safety regulations in diverse workplace settings.



3. Elevating Work Platform Licence (WP)

TLILICO005 Licence to operate a boom-type elevating work platform (boom length 11 metres or more)

EWP

This course provides a pathway to obtain a boom lift licence (class WP). This course provides training in the skills and knowledge required to safely operate a boom-type Elevating Work Platform (EWP) where the length of the boom is 11 metres or more in accordance with all relevant legislative requirements.



4. Reach Stacker Licence (RS)

TLILICOO11 Licence to operate a reach stacker (greater than 3 tonnes capacity)

REACH STACKER

This course provides a pathway to obtain a reach stacker licence (class RS). This unit specifies the skills and knowledge required to operate a reach stacker safely. Reach stacker means a powered reach stacker that incorporates an attachment for lifting and lowering a shipping container (capacity greater than 3 tonnes).





REFRESHER TRAINING.

All businesses that employ a forklift operator have a responsibility to ensure that these people are suitably trained and competent. Our experience has proven that an ongoing refresher training programme is an excellent way of achieving compliance in this area and has a massive impact on changing the culture of safety within a business.



5. Platinum level Refresher Training

Platinum Level – our highly customised training program. We take onboard your SOP's and particular site requirements and develop the programme, including all training materials, specific to your workplace operations. This includes theory and practical training, as well as the completion of individual verification of competencies. (4 hour session – 6 operators per session – up to 2 sessions per day)



6. Gold level Refresher Training

Gold Level – our standard refresher training and verification of competence program. This programme would be described as best practice. This session comprises theory and practical components including a knowledge assessment. It also incorporates the completion of individual verification of competencies. (4 hour session – 6 operators per session – up to 2 sessions per day).



7. Silver level Refresher Training

Silver Level – this is the same program as the bronze level just with smaller groups. This is for those businesses that cannot afford to have large numbers of operators off the floor at any given time. (2.5 hour session – 4 operators per session – 2 sessions per day)

8. Bronze level Refresher Training

Bronze Level – this is our basic standard of refresher training. It incorporates theory and practical refresher training. This course is designed for those who wish to refresh their skills and knowledge in line with current legislation requirements. This program does not include individual verification of competencies.

(3.5 hour session – 8 operators per session – up to 2 sessions per day)



9. Verification of Competence (VoC)

Verification of Competence (VoC) – this allows us to measure the operator's ability to demonstrate their competence. Each operator is provided with a comprehensive competence report. This can be completed as a stand-alone exercise, often valuable to complete following an incident or as an induction.

OTHER TYPES OF TRAINING







10. Pedestrian operated equipment training (walkie stacker, pallet trucks etc)

This includes comprehensive training for equipment such as walkie stackers, pallet movers and electric pallet jacks. This programme is a great way to ensure all operators as suitably trained and competent in all the pedestrian operated equipment they are operating.



11. Forklift load handling attachment use and safety

There are hundreds of load handling attachments available for forklifts. Some examples are long tynes, clamp attachments, personnel platforms. Each one requires different skills and knowledge to use. This course is specifically tailored to the load handling attachments that your business and operators utilise. The course also covers the compliance aspects of such load handling attachments.



12. Skills upgrade training i.e. (Counterbalance to reach forklift)

The material handling equipment industry is an ever-changing landscape. New and innovative equipment is constantly being introduced. We aim to eliminate the overwhelming situation by providing you with high-quality up-skilling training solutions and courses that fully encompass the shifting tides of the industry. Examples include training in high reach forklifts, turret trucks and multi-directional forklifts.)

13. Forklift Battery charging and changing safety

Battery Electric forklifts make up over 50% of all forklifts used now. Operators must know how to safely charge these batteries and, in some cases, even how to change the batteries. This course covers the skills and knowledge required for the charging and/or changing of the type of batteries in use at your business.

STOCK MOVEMENT

EQUIPMENT

14. Stock movement equipment.

Most warehouses utilise some sort of equipment for moving stock around at floor level. These could be stock-chasers, tugs, burden carriers or many other types. The WHS/OHS Regulations require that users are competent on all types of equipment used not just the ones that require high risk work licence like forklifts.



15. Storage Racking Training

Are your staff familiar with the requirements and skills required for your storage racking? Does your business use different types of racking ?

STORAGE Racking

NATIONALLY RECOGNISED TRAINING UNITS







HEIGHT SAFETY

16. RIIWHS204E Work Safely at Heights (Working at Heights)

This course is designed to equip learners with the knowledge and skills to safely work in any height situation. Primarily aimed at warehousing, logistics and manufacturing environments, or in other situations where work is conducted in a place where a fall from one level to another is possible.



GANTRY CRANE

17. RIIHAN305D Operate a gantry or overhead crane

This course covers the requirements for operating a gantry or overhead crane which is controlled by pendant or wireless remote. Successfully completing this course will allow you to operate any gantry, bridge, jib or wall mounted crane with three (3) or less powered motions.



18. TLID0006 Move materials mechanically using automated equipment

WALKIE STACKER

This unit involves the skills and knowledge required to move materials mechanically using automated equipment. It includes selecting appropriate automated mechanical moving equipment, moving materials in accordance with operational requirements, checking condition of materials and completing required records. This type of equipment includes walkie stackers and electric pallet jacks.



FORKLIFT

19. TLID0016 Operate a forklift

This is a Nationally Recognised Training forklift refresher course. This course gives the operator current industry forklift skills required to keep competent. It also ensures the employer is meeting legislative training requirements. This course offers the information and skills required within current legislation to operate a forklift truck.



MANUAL Handling

20. TLID0020 Shift materials safely using manual handling methods (Manual Handling)

This is a Nationally Recognised Training manual handling training course. This course will help learners understand what risks are associated with performing manual handling tasks and how to minimise those risks by following the correct procedures for performing those tasks. This includes managing risks of hazardous manual tasks, plant and environment.



21. TLID3011 Conduct specialised forklift operations

For persons currently employed in industry and holding a forklift licence class LF with a requirement to upgrade their forklift operating skills with more specialised equipment. This specialised equipment may be unusual types of forklifts or even load handling attachments.



22. HLTAID011 Provide First Aid

This course is for people employed as first aiders and those with a duty of care to provide first aid to others. This includes workers with a duty of care for vulnerable clients, child care educators, teachers, emergency services personnel, workers in hazardous environments and nominated workplace first aiders.

EWP YELLOW CARD TRAINING

The EWPA Yellow Card Training Program has been designed for people needing to develop the skills and knowledge required to operate Mobile Elevating Work Platforms (MEWPs or commonly known as EWPs). The course will provide training in the safe use of various types of elevating work platforms including boom type EWPs with boom length under 11 metres. Participants may complete single or multiple modules, depending on the type of EWP they will be operating:



23. (Yellow Card SL) Scissor lift

These are an EWP with a scissor type elevating stack. No High Risk Work licence is required however under the WHS legislation an employer must provide adequate information, training and instruction. Trainees who successfully complete this course will be issued an SL class YELLOW CARD from the EWPA.



24. (Yellow Card VL) Vertical lift

These are an EWP with a vertical type elevating mechanism. This may be like a mast or extending post. Again, no High Risk Work licence is required however under the WHS legislation an employer must provide adequate information, training and instruction. Trainees who successfully complete this course will be issued a VL class YELLOW CARD from the EWPA.



25. (Yellow Card BL) Boom lift

These are an EWP with a boom. These may be straight boom type or articulated. No High Risk Work licence is required so long as the boom length is less than 11 metres. under the WHS legislation an employer must provide adequate information, training and instruction. Trainees who successfully complete this course will be issued a BL class YELLOW CARD from the EWPA. Where the boom length is 11 metres or more, a High Risk Work licence is required. See item 3 above.



TRUCK MOUNTED

26. (Yellow Card TM) Truck mounted

These are an EWP that is mounted on a truck. Commonly these are either boom lift or scissor lift. Again, no High Risk Work licence is required so long as the boom length is less than 11 metres. Under the WHS legislation an employer must provide adequate information, training and instruction. Trainees who successfully complete this course will be issued a TM class YELLOW CARD from the EWPA Where the boom length is 11 metres or more, a High Risk Work licence is required. See item 3 above.



27 . (Yellow Card TL) Trailer mounted

TRAILER MOUNTED

These are an EWP that is mounted on a trailer. Commonly these are either boom lift or scissor lift. Again, no High Risk Work licence is required so long as the boom length is less than 11 metres. Under the WHS legislation an employer must provide adequate information, training and instruction. Trainees who successfully complete this course will be issued a TL class YELLOW CARD from the EWPA. Where the boom length is 11 metres or more, a High Risk Work licence is required. See item 3 above.

TELESCOPIC HANDLER

28. (Gold Card) Telescopic Handler

The course will provide training in the safe use of various types of Telehandler and attachment combination that does not require a HRW licence. Participants may complete singular or multiple modules according to the Telehandler and attachment combination they will be operating.

Note: A High Risk Work licence may be required. Please call for further information.

COMPLIANCE

29. Forklift compliance for forklift suppliers and hirers

If your business supplies or rents any type of forklifts, then your business has direct responsibilities under the WHS Legislation. You also have a responsibility to understand the current "state of knowledge". Let Forkpro Australia work with you to help understand your responsibilities

30. Elevating Work Platform compliance for EWP suppliers and hirers

The same as the above however this course applies to elevating work platform supply. Different regulations and standards apply for EWPs including when a High Risk Licence is required. EWPs also require design registration which is another level of compliance.



KNOWLEDGE & COMPLIANCE

31. Order Picking forklift compliance for forklift suppliers and hirers

This course is similar to the above however for the supply or rental of order picking forklifts or turret trucks. There is a lot of confusion within the market as to the designation of certain machines and whether they fall under "order picker" categories. Again, Forkpro Australia can provide all the required information for this segment.



32. Forklift safety for managers and supervisors



Are your managers and supervisors familiar with all the legislation and standards that apply to plant equipment operation? This course is designed to provide that knowledge and look at how to implement it into your business and its systems of work. We can tailor the content to suit the type of equipment in operation.

33. Pedestrian Safety in the Workplace

Did You Know that nearly every workplace pedestrian accident occurs as a direct result of mobile equipment operators not seeing or hearing the person and visa versa. 34. Industrial Traffic Management review

State and territory legislation requires that plant equipment must not be able to collide with pedestrians. Forkpro Australia has many years of experience with the methods to prevent this. We can come to your site to undertake a review of current practices vs best practice and provide a written report.



35. Forklift safety consultation

Compliance with related standards such as AS2359 and best practice requires a constant handle on the ever-changing requirements. Forkpro Australia staff are embedded in these processes and can provide valuable information to your business. Again, we can provide site visits and written follow up report.



36. Legal expert witness

37. Height safety equipment inspection in accordance with AS NZS1891.4 Australian Standard AS NZS1891.4 requires that height safety equipment such as harnesses, lanyard, and other equipment is inspected by a competent person at specified intervals (generally 6 monthly). The competent person is quite specifically defined and Forkpro Australia has Inspectors available to inspect and report on the equipment at your site.



38. Training Card.

If required, Forkpro Australia are able to issue training ID cards once proper training has been completed. These can be customised for your company and may also include photos where desired.

ROAD TRANSPORT TRAINING COURSES



39. TLIA1001 Secure cargo

This course involves the skills and knowledge required to secure cargo, in accordance with procedures and regulatory requirements, as part of work activities within the transport and logistics industry. It includes preparing to secure cargo/containers, lashing and unlashing cargo, protecting cargo from weather and packing and unpacking cargo.



40. TLID0015 Load and unload goods/cargo.

LOAD AND UNLOAD Goods/cargo This course involves the skills and knowledge required to load and unload goods and/or cargo. It includes loading and unloading goods and cargo, securing and protecting a load and completing all required documentation in accordance with relevant state or territory roads and traffic authority regulations and permit requirements..



41. TLIF0005 Apply a fatigue risk management system.

This course is designed to equip heavy vehicle drivers with the skills and knowledge required to manage fatigue and to work safely within the Transport and Logistics industry.

It includes applying fatigue risk management strategies, identifying and acting on signs of fatigue, operating within a fatigue risk management system, planning and navigating trips, updating and maintaining records, Complying with work and rest limits, and implementing appropriate strategies to minimise fatigue during work activities. Being awarded this course of competency is a necessary requirement to operate under a National Heavy Vehicle Regulator (NHVR) Basic Fatigue Management Accreditation under the National Heavy Vehicle Accreditation Scheme (NHVAS).



ROAD TRANSPORT TRAINING COURSES







42. TLIF0006 Administer a fatigue risk management system.

This course is designed to provide road transport schedulers or supervisors/managers with the skills and knowledge required to administer a fatigue risk management system within. the Transport and Logistics industry These managers must have responsibility for providing any directions when to drive/work and rest that will be acted upon by a heavy vehicle operator.

It includes identifying and managing risks associated with fatigue during heavy vehicle driving, operating within a fatigue risk management system, planning trips and updating records, and developing and implementing policies, procedure and strategies to minimise fatigue in the workplace.

Being awarded this course of competency is a necessary requirement to operate under a National Heavy Vehicle Regulator (NHVR) Advanced Fatigue Management Accreditation under the National Heavy Vehicle Accreditation Scheme (NHVAS). This course will allow the learner to participate as a scheduler within a transport provider.



TRAFFIC MANAGEMENT

43. TLIF0009 Ensure the safety of transport activities (Chain of Responsibility) This course involves the skills and knowledge required to ensure the safety of transport activities.

It includes identifying features and applying chain of responsibility obligation in the Heavy Vehicle National Law (HVNL) or applicable state/territory law and regulations. It also includes identifying and reporting chain of responsibility risks. This course is designed for participants already working in the transport and logistics industry. Job roles and titles vary across different sectors but is generally aimed at those people working within general transport or logistics roles.



SAFETY

44. TLIFOO80 Implement and monitor the safety of transport activities (Chain of Responsibility)
This course involves the skills and knowledge required to monitor the safety of transport activities.
It includes determining and monitoring chain of responsibility features in the Heavy Vehicle National Law (HVNL)
or applicable state/territory law and regulations. It also involves administering and monitoring chain of responsibility
workplace policies and procedures and identifying and reporting chain of responsibility risks.
This course is designed for participants already working in the transport and logistics industry.
This course applies to any person who has influence or control responsibilities of a business' transport activities, hazards, risks and risk control under certain job functions.
